# **Online Facility Guide**

The Tribunal Meeting and the General Meeting (the "**Scheme Meetings**") can be accessed online using your smartphone, tablet or computer. There will be no physical meeting for DP World Beneficial Shareholders to attend in person or by personal representative(s). If you have a NIN Account, you will be able to listen to a live webcast of the meeting, view slides (if any), ask the Directors questions in written form and submit your votes in real time. If you do not have a NIN Account, you can attend online but cannot ask questions or vote. To access the Online Facility, you will need to either:

- a) Download the Lumi AGM app from the Apple App or Google Play Stores by searching for Lumi AGM; or
- b) Visit https://web.lumiagm.com on your smartphone, tablet or computer. You will need the latest versions of Chrome, Safari, Internet Explorer 11, Edge and Firefox. Please ensure your browser is compatible.

#### Using the Online Facility:

# **ACCESS**

Once you have either downloaded the **Lumi AGM app** or entered **web.lumiagm.com** into your web browser, you'll be prompted to enter the Meeting ID (set out above)

You will then be required to enter your:

- a) NIN; and
- b) password.

You will be able to log into the Online Facility from 2.00 pm (UAE time), Wednesday 22<sup>nd</sup> April 2020. If you are a DP World Beneficial Shareholder with a NIN Account, select 'I have a login' and enter your NIN and password. Passwords will be distributed following completion and submission of your Voting Instruction Form

If you do not have a NIN Account, select 'I am a guest' - as a guest, you will be prompted to complete all the relevant fields including: title, first name, last name and email address.

#### Please note, guests will not be able to ask questions or vote at the meeting.

### NAVIGATION

When successfully authenticated, the info screen will be displayed. If you have a NIN Account, you can view company information, submit written questions and listen to the audiocast. If you do not have a NIN Account, you can view company information and listen to the audiocast.

If you would like to listen to the **audiocast** press the broadcast icon imat the bottom of the screen.





# VOTING

If you have a NIN Account, the Chair will open voting on all resolutions at the start of the meeting. Once the voting has opened, a will appear on the navigation bar at the bottom of the screen. From here, the resolutions and voting choices will be displayed. To vote, simply select your voting direction from the options shown on screen.
