

## PRIVACY POLICY REGARDING THE REGISTRATION OF VISITORS

If you wish to visit (one of) the business premises (terminals) of the DP World group companies (hereinafter: "DP World") at the port of Antwerp, you need to register in advance. By means of this registration, you pass on certain personal data, about yourself or another person, and you agree that we, DP World Antwerp Holding NV, with registered office at Molenweg (KAL), Haven 1950, 9130 Beveren, Belgium and registered in the Crossroads Bank of Enterprises under number 0406.070.605 will process these personal data. We may also obtain these personal data through other channels (such as the Neo platform for taking a security test or Alfapass).

It will mainly concern the following personal data: your first and last name, date of birth, national registration number and, if applicable, license plate number, mobile phone number and nationality, and the test result of the Neo platform. When you actually visit the premises, you will in all likelihood also be filmed. DP World processes your personal data in the capacity of data controller as stipulated by the Regulation (EU) 2016/679, known as General Data Protection Regulation (GDPR).

If you provide us personal data of others, you guarantee that they were collected in compliance with applicable legislation and that the data subjects concerned were inter alia sufficiently informed.

The processing of the personal data is based upon article 6.1. a) consent, b) necessary for the performance of a contract, 6.1. c) necessary for compliance with a legal obligation and/or f) legitimate interest of the GDPR. To the extent that the processing is based upon consent, you can withdraw your consent at any time.

Personal data will be processed for general safety, security and access control purposes and to enable DP World to comply with its obligations under the International Ship and Port Facility Security Code (ISPS) and European Regulation n°725/2004.

To the extent required to carry-out the aforementioned purposes, we may share the personal data with other companies within the DP World group and/or transfer them to one of our partners (e.g. IT service providers). We will ensure that these recipients undertake to process the personal data in compliance with applicable legislation. If these recipients process your personal data outside of the European Economic Area, we will use our best efforts to take the necessary contractual and/or other safeguards in this regard (e.g. EC Standard Clauses or similar contractual safeguards) in order for your personal data to have an adequate level of protection.

You are at all times entitled to access your personal data and have them corrected when inaccurate or incomplete, to have them erased and to have the processing thereof restricted, when the legal conditions thereto are met.

You have the right to receive a copy of your personal data (in a structured, commonly used and machine-readable format) and to have the personal data transferred to another controller (right to data portability) and the right to object to the processing of your personal data, if the legal conditions hereto are met and the right to object to the processing of your personal data.
