- All DG containers with the exception of IMCO Class 1 and Class 7 will be kept in the terminal for a maximum of 3 days, by which time the consignee must arrange for delivery of the containers.
- Failure by the consignee to take delivery within 3 days will result in the containers being transferred to the isolation area.

- IMCO Class 1 and Class 7 containers entering the Port without prior approval from the SPA.
- Non-declaration or mis-declaration of DG containers.
- DG containers not displaying correct placarding or not having any placarding.

Undeclared container without any incident	3000 USD per container
Undeclared container resulting in an incident	3000 USD per container + incident cost

- No import DG containers will be accepted in the Port for re-export to Yemen by sea.
- DG containers for re-export by land will be accepted in line with the above procedures.
