## Definition of terms

<b>Term</b>	<b>Definition</b>
<b>Special Service Request (SSR)</b>	A request to change a piece of information or request additional services to the container whilst at the Port Premises, these requests are sent by the shipping line via CNS.
<b>Priced on Application (POA)</b>	The prices may differ and costs will be arranged on a case-by-case basis. We will seek acceptance of costs before proceeding with any work or service carried out.
<b>Hatch Cover</b>	Hatch covers or Lids separate the upper deck and lower deck of the vessels, we charge per move both off and back onto the vessels to be able to work the under deck and upper deck levels.
<b>Lashing</b>	The securing of the containers when stowed onto the vessel
<b>Twenty-foot equivalent Unit (TEU)</b>	When charging by TEU the base rate will correspond to 20'ft containers, the rate will double for 40' container and unless otherwise stated treble for 45'ft containers.
<b>Nested Flats</b>	Empty flat-rack units stacked on top of each other (up to 4) these will be moved together as one single unit and charge one fee. So Full mainline rate refers to the pricing of moving up to x4 stacked flat racks as a bundle. We also charge for Bundling and unbundling these stack or nested flats to create or dismantle these bundles.
<b>Port Premises</b>	The container terminal at Southampton and any land thereon or adjacent thereto leased or otherwise occupied by the Supplier for the purposes of the Services.
<b>IMDG</b>	International Maritime Dangerous Goods containers not including Class 1 or Class 7
<b>VGM</b>	Verified Gross Mass
<b>OCR</b>	Optical Character Recognition
<b>VBS</b>	Vehicle Booking System
<b>London Gateway Estate</b>	DP World London Gateway Estate means the Port Premises and the DP World London Gateway Logistics Park'

## 1.10. Mooring and Unmooring

Vessel mooring and unmooring at the Port Premises will be performed by the terminal's shore-based personnel and charges are applied to the vessel operator, dependent on vessel size.

From the 1<sup>st</sup> of June 2020, a penalty charge of £1,000 per instance will apply to vessel found to be using Dangerously Weighted Heaving Lines (DWHL). This charge is donated to charity.

## 1.11. Vessel Solid Waste Reception

Unless exempted, all vessels calling at the Port Premises are required to pay a charge towards the cost of waste reception as follows:

### 3.1 Vehicle Booking System Process

A VBS Booking is required for all haulier collections / Deliveries at the Port Premises. #### **Driver ID Cards**

To comply with DFT rules and regulations, together with assisting haulage firms with the management of obtaining Driver ID Cards, please note the below:

Drivers MUST have the correct documentation to enter the Port Premises. Without this, entry will be refused.

- Temporary ID Card – Driving Licence
- Permanent ID Card – Two forms of ID are required. Driving Licence, plus passport, birth certificate, EU ID card, or Tachograph card.

Drivers are required to have either a Temporary or Permanent Driver ID Card to enter the Port Premises. Both Temporary and Permanent ID Cards can be requested at the Gate Service Office. The charge will be applied to the company that is linked to the Driver's VBS booking and will appear on the monthly invoice.

In order for Haulage companies to have visibility on Driver ID Charges being accumulated, an automated daily report is sent to registered hauliers via email.

Drivers arriving at the Port Premises requiring a driver ID card should leave extra time for entering the Port Premises and follow instructions given by our security personnel.

**All drivers arriving at the Port must also have a valid VBS slot.**
