SECTION A - DEFINITIONS

A101. CARGO

Any solid, liquid, or gaseous substance, product or Hazardous Material transported to, from, in or through the jurisdiction of the Port Authority and involving the use of Port's Facilities.

A102. DAY

A calendar day

A103. HAZARDOUS MATERIAL(S)

Any substance or material that is listed, defined or otherwise designated as (a) "Hazardous Substance" under the Regulations including IMDG Code; (b) any chemical or Volatile Organic Compound (VOC); (c) any hydrocarbons, petroleum, petroleum products or waste; (d) any metabolite or chemical breakdown product or derivative or component part of substances identified above; and (e) any other chemical, substance or waste, that is regulated by, or may form the basis of liability under, any Environmental Laws.

Dangerous Goods -

Any of the following cargoes, whether packaged, carried in bulk packaging or in bulk, within the scope of the following instruments:

- Oils covered by Annex I of MARPOL 73/78
- Gases covered by the codes for the construction and equipment of ships carrying liquefied gases in Bulk
- Noxious liquid substances/chemicals, including wastes, covered by the codes for the construction and equipment of ships carrying dangerous chemicals in bulk and Annex II of MARPOL 73/78
- Solid bulk materials possessing chemical hazards and solid bulk materials hazardous only in bulk (MHBs), including wastes, covered by group B schedules in the Code of Safe Practice for Solid Bulk Cargoes (BC Code)
- Harmful substances in packaged form (covered by Annex III of MARPOL 73/78) and dangerous goods, whether substances, materials, or articles (covered by the IMDG Code)

The term dangerous goods includes any empty uncleansed packaging which previously contained dangerous cargoes, unless the packaging have been sufficiently cleaned of residue of the dangerous cargoes and purged of vapours so as to nullify any hazard or have been filled with substances not classified as being dangerous.

A104. PORT AUTHORITY

Porto De Luanda E.P.

A105. PORT OPERATOR

DP World MPL Servicos, S.A.

A105.1 TERMINAL OPERATOR will also refer to A105 as the Port Operator

A106. PORT FACILITIES

Any wharves, docks, piers, sea channels, sheds, warehouses, land, structures, pipelines, and extensions thereof and appurtenances there to, equipment and appliances of all kinds situated within the jurisdiction of and/or owned, operated, or leased by the Port Operator.

A107. USER

Includes (1) any person or entity using the Port facilities or to/from whom any service, work or Labour is furnished, performed, done or made available by the Port Operator or any other person using the Port Facilities, (2) any person or entity owning or having custody of Cargo moving in, over or through the Port Facilities; (3) all Vessels and their owners, operators, crew and agents; and (4) any other person, firm or corporation that conducts business at the Port facilities.

A108. VESSEL

Except as otherwise specified, when the term "Vessel" is used in this Tariff, it shall be held to mean floating craft of every description and shall include in it meaning the term "Owners, Charterers, Operators and Mortgagees thereof".

A109. SERVICES

Any and all services conducted within the Port Facilities.

A110. TON

Unless otherwise specified, all "Tons" shall be regarded as "Freight Tons" and shall be determined by a weight Tonne of 1,000 kilos or a measurement of one cubic meter whichever is greater.

A111. STEVEDORING

The physical handling of Cargo on-board of the Vessel from or to the Vessel's hook or point of discharge or load. This includes supervision and management. Irrespective of the terms of shipment, payment of stevedoring and related service charges will be the responsibility of the shipping line and/or his agent.

A112. CONTAINER

The terms "Container" or "Containerised" when used in this Tariff refer to the standard ISO Container, suitable for stacking and transportation of dry, liquid gas or refrigerated Cargo, constructed of metal, fibreglass, plastic, or wood, which confines its contents and must be capable of being handled as a unit and lifted by a crane with a Container spreader.

A113. POINT OF REST

The area at the Port which is assigned for the receipt of inbound Cargo or Container from the Vessel and from which inbound Cargo or Container may be delivered to the Consignee's Agent or loaded on a Vessel in the case of transhipment and that area which is assigned for the receipt of outbound Cargo or Container from Shipper's Agents for loading on-board a Vessel.

A114. OPEN/COVERED STORAGE, PARKING AREA AND/OR MARSHALLING AREA

The term open/covered storage, parking area and/or marshalling area, as used in this Tariff, refers to those areas at the Port Facility where Cargo or Containers may be held in custody of the Port Operator as instructed by the Owner or Agent. This area is considered as Port Facility storage.

A115. FREE TIME

The specified period during which Cargo or Containers handled over the quay may occupy space assigned to it in the Port Facility, free of storage charges, either prior to the loading or subsequent to the discharge of such Cargo or Containers, and shall include:

a) Import and Transhipment Container free period will commence from the date of discharge from the Vessel;

- b) Import and Transhipment non-Containerised Cargo free period will commence from the date of completion of off-loading of the Vessel or on the third day from commencement of operation whichever occurs first; and
- c) Export Containers and non-Containerised Cargo free period will start from the date of receipt in Port Facilities.

Note: Export and Transhipment Cargo storage charges will be raised to the Agent.

A116. TRANSHIPMENT

"Transhipment Cargo or transhipment Container" means goods / containers landed from a Vessel and placed in the custody of the Terminal in Port of Luanda for the purpose of shipment on another Vessel with final destination other than Port of Luanda. To qualify for the transhipment Cargo rates the cargo/containers must be discharged by the first carrier onto the terminal Operator and remain in the custody of the Terminal Operator until it is transhipped on-board the on-carrying Vessel with final destination. Cargo landed from a Vessel and placed in the custody of the Terminal Operator with intention to be transferred to other Terminal operator within Port of Luanda as final destination will be considered import & export cargo.

A117. OTHER MEASUREMENT UNITS

A117.1 By weight: the unit of application is the indivisible metric ton, unless otherwise indicated in the table itself;

A117.2 By volume: the unit of application is the indivisible cubic meter, unless otherwise indicated in the table itself;

A117.3 By surface: the unit of application is the indivisible square meter;

A117.4 By length: the unit of application is the indivisible linear meter (m); or if specified will be indivisible feet (ft)

A117.5 By time: the unit of application is the indivisible hour or indivisible day, unless otherwise indicated in the table itself;

A117.6 Per kilowatt/hour: the unit of application is the indivisible kWh;

A117.7 Per unit: the unit of application is the one set out in the respective fee tables;

A117.8 By tonnage: the unit of application is the gross registered tonnage (GRT) of vessels;

A117.9 By TEU: the volume and shape that are equivalent to a 20-feet ISO container. Container defined as per A112

B103. STEVEDORING for DANGEROUS HAZARDOUS OR OBNOXIOUS CARGO

- **B103.1** Articles of a dangerous, hazardous, or obnoxious nature will only be received at Port Facilities by advance arrangement with the Port Operator in conjunction with the Port Authority. The Port Operator and the Port Authority reserves the right to refuse or handle any Cargo or provide storage which in its judgment is likely to damage human health, other Cargo, or property.
- **B103.2** HAZARDOUS CONTAINERS SURCHARGE: Containers loaded with hazardous Cargo will be charged an extra of 50% on the applicable stevedoring charges as per B101.
- **B103.3** Other charges and fines for hazardous Cargo violations and leaking Containers may be levied at the discretion of the Terminal Operator.

B104. STEVEDORING for OVER DIMENSIONAL CONTAINERS (OOG or Out of Gauge Containers)

- **B104. 1** Containers carrying Over Dimensional cargo beyond the normal size of standard containers OR needing special devices like slings, shackles, lifting beam, etc. are termed as Over Dimensional Cargo Containers. They also include damaged containers and other types of containers that require special devices to handle them.
- **B104.2** Charges for Full & Empty Over Dimensional Containers will be charged an extra of 100% above Full and Empty Normal Containers as per B101.
- **B104.3** Further depending on the size and the complexity of handling the OOG Containers, the Terminal operator reserves the right to charge additional stevedoring charges basis the equivalent of the slots occupied on the vessel, as per B101.
- **B104.4** Any additional equipment required to handle OOG containers will be billed additionally as per the discretion of the Terminal operator.

B104.5 All Over Dimensional Containers required advance notification and approval from the Port operator before commencement of Operations

B107. TRANSHIPMENT CONTAINERS

B107.1 Transhipment Cargo or transhipment Container" means goods / containers landed from a Vessel and placed in the custody of the Terminal in Port of Luanda for the purpose of shipment on another Vessel with final destination other than Port of Luanda. To qualify for the transhipment Cargo rates the cargo/containers must be discharged by the first carrier onto the terminal Operator and remain in the custody of the Terminal Operator until it is transhipped on-board the on-carrying Vessel with final destination. Cargo landed from a Vessel and placed in the custody of the Terminal Operator with intention to be transferred to other Terminal operator within Port of Luanda as final destination will be considered import & export cargo.
