- 2. Risk Reduction and Improvement: Through proactive identification, planning and action, we eliminate and/or minimize risk that make our workplace unsafe or harm environment.
- 3. Commitments We Live By: We all take personal responsibility for QHSE in our workplace as a core value. We follow fundamental behaviors to live by every day.

- · We measure our success by the health of our people and the environment
- Our management and people are accountable and enabled to address QHSE Matters.
- Our QHSE strategies are adaptive and evolve to our business's needs to ensure customer satisfaction.
- · We are always improving our QHSE systems and pushing our boundaries.
- We set clear, measurable QHSE targets that are aligned with our operational performance.
- We strive to eliminate serious incidents in our business through HSE assurance activities and risk reduction programs
- We implement programs to protect the health of our workers.
- · We proactively identify and manage hazards and risks.
- We embed QHSE messaging in our daily communications
- We strive to set the standards for our industry and fulfil all regulatory requirements.
- · We listen to our people and consult and involve them in our quality, health, safety and environment decisions
- We provide training, engagement opportunities and information to our people to enhance competency and capability to work safely.
- We remain responsible and commit to efficient use of natural resources protection of biodiversity and ecosystems.
- We prevent, reduce and manage releases and waste
- We implement leading sustainability practices, climate change mitigation and decarbonization strategy to reduce emissions

- Operations are stopped and corrected if a risk of a serious QHSE incident is present by invoking STOP WORK AUTHORITY at the first sign of hazard and ensure to perform TAKE TIME prior to commencement of any job/task.
- · We monitor and measure our HSE performance
- We implement pollution prevention programs and lead sustainability practices.
