NOTES:

- 1. VGM processing fee applies to all export and transshipment containers (checking for VGM existence).
- 2. Late arrival fee applies when unit arrives in the terminal while vessel is alongside or under operations.
- 3. Cyber security fee applies to all containers loaded onto/discharged from vessels.
- 4. Sanitary surcharge applies to all containers loaded onto/discharged from vessels.
- 5. ISPS surcharge applies to all containers loaded onto/discharged from vessels.
- 6. Green fee applies to all containers loaded onto/discharged from vessels.
- 7. Container scanning applies to all import and transshipment full units discharged from vessels.
- 8. Container inspection (per empty unit) includes a minimum of six (6) pictures, for a detailed assessment.
- 9. Pictures of container condition (not part of the inspection process), includes a set of six (6) pictures.
- 10. Should storage for full containers exceed the number of free days pertaining to each category, storage will be charged retroactively starting with containers date of discharge.
- 11. Data amendment is charged for any change to the pre-advised particulars pertaining to that Container whilst it is within the Terminal and is to be manually operated in the system.
- 12. Miss-declaration is charged for all containers where discrepancies between their pre-advised particulars and their physical status are being found whilst the containers are discharged in the terminal.
- 13. Twist-lock bin is charged as a restow 40' FCL Container via Quay.
- 14. All 40' Container quayside handling rates also apply to 45' containers provided they are less than 5% of the total 40' units handled. Should they exceed the specified percentage, then a premium of 25% over the 40' unit handling rate shall apply.
- 15. Due to specific location requirements within the yard, the storage of OOG and 45' Containers will attract a 25% premium over the equivalent storage rate for a 40' Container.
- 16. Transshipment container FCL or EMTY count as full cycle (cell first vessel until cell second vessel).
- 17. Reefer rate includes plug/unplug, monitoring of power supply, observing set-points, provision of power supply via main electricity, notification of malfunctions or power outage. It excludes any additional lifts for repairs or investigations accessible to the Customers contractors or representatives.
- 18. Shut out at shipside or already move is charged for containers already taken from the stack for delivery to the vessel where the Customer request for that container not to be shipped.
- 19. Vessels out of window will attract a 25% increase over the normal handling rates.
- 20. Vessels operated during the weekend Fri 19:00 Mon 07:00, or bank holidays attract a surcharge of 25% over normal handling rates.
- 21. Terminal reserves the right to revisit the public rate schedule as the market situation develops further in relation to costs.
