- Performs and completes root cause analysis on mobile heavy equipment, light vehicles and facilities equipment and associated parts/components, independently. - Maintains a clean and orderly workplace during and after repairs/ maintenance activities. Applies the 6S methodology at all work areas.




#### The Mechanic has:


